Mill & Overlay Project

The City of Morenci is seeking sealed-bids at its office at 118 Orchard Street, Morenci, Michigan 49256, until 5:45 p.m., Wednesday, June 7, 2017, for a two (2) inch mill and overlay of East Street North between East Locust Street and East Main Street.

Notes to Bidders

1. Please indicate clearly any substitutions contained in your bid and which alternates or combinations of same are included in your bid.
2. The bidder is responsible for taking actual measurements of the area to be milled and overlaid. Area to be milled and overlaid is identified in the enclosed map. ENCLOSURE 1
3. The City of Morenci will hold the successful bid prices firm for a period not to exceed one (1) months from the date of the bid closing.
4. The successful bidder shall provide proof of worker's compensation (statutory limits) and public liability and property damage insurance in the amount of \$1,000,000.00 with the City of Morenci named as additional insured.
5. References and information on previous jobs is required to be provided to the City of Morenci with this proposal.
6. All mill and overlay work must be completed prior to August 31, 2017, but shall not start until after July 1, 2017.
8. The City of Morenci requires a warranty on material and labor and it is to be written on the proposal sheet.

10. Bids shall be provided for area with a total cost noted at the end of the bid.
11. Envelope(s) must be plainly marked BID, with the purpose and time of opening.
12. Bids must be submitted on the bid sheet.

Bids must be received by 5:45 p.m., Wednesday, June 7, 2017, at 118 Orchard Street, Morenci, MI 49256. Bids will be publicly opened, read and available for review at the time specified. Following the bid opening, the bids are reviewed by various staff members in order to make a recommendation to the Morenci City Council at its next regular meeting. Bids will be awarded at the next regularly scheduled Morenci City Council meeting following the due date for receipt of bids.

The right is reserved by the City of Morenci to reject any and all bids or any part of same, to waive irregularities and / or informalities, and to make the award or acceptance in part or entirety as may appear to the best interest of the City of Morenci. Any dispute arising as to any bid shall be settled in the sole discretion of the Morenci City Council.
