The City of Morenci is seeking sealed-bids at its office at 118 Orchard Street, Morenci, Michigan 49256, until 4:00 p.m., Thursday, September 24, 2015, to chip brush at the City of Morenci's DPW facility.

Notes to Bidders

1. Please indicate clearly any substitutions contained in your bid and which alternates or combinations of it are included in your bid.
2. Bid should include price to chip brush at the City's DPW facility. Chipped brush may stay at the DPW facility and does not need to be removed from the site. Chipped brush should be piled neatly at the site after it is has been chipped.
3. The City of Morenci will hold the successful bid price firm until the work is complete by the successful bidder. Please note that the City of Morenci would like the work completed by October 31, 2015; however, it is recognized that such may not be possible, in which the bidder on the bid sheet shall then specify a timeframe.
4. By placing a bid, the successful Company agrees to hold harmless the City of Morenci from all liability.

6. Envelope(s) must be plainly marked BID, with the purpose and time of opening.
7. Bids must be submitted on the bid sheet.

Company providing work must provide proof of liability insurance to the City of Morenci and name the City of Morenci as additionally insured upon acceptance of bid by the Morenci City Council. Bids must be received by 4:00 p.m. on Thursday, September 24, 2015, at 118 Orchard Street, Morenci, MI 49256.

Work must be completed by October 31, 2015. (If work cannot be completed by such date, please specify a timeframe on the bid sheet for when such work will be completed by.)

The right is reserved by the City of Morenci to reject any and all bids or any part of same, to waive irregularities and / or informalities, and to make the award or acceptance in part or entirety as may appear to the best interest of the City of Morenci. Any dispute arising as to any bid shall be settled in the sole discretion of the Morenci City Council.
