The City of Morenci is seeking sealed-bids at its office at 118 Orchard Street, Morenci, Michigan 49256, until 5:45 p.m., Tuesday, October 21, 2014 for the purchase of either one (1) 2014 / 2015 Ford Police Interceptor Utility All-Wheel Drive or one (1) 2014 / 2015 Chevrolet Tahoe PPV.

General Specifications

The City of Morenci requires that the general specifications of the 2014 / 2015 Ford Police Interceptor Utility All-Wheel Drive vehicle or 2014 / 2015 Chevrolet Tahoe PPV vehicle have the following features:

The City of Morenci will only be purchasing one (1) vehicle.

Warranties

The successful Bidder shall provide any / all available warranties that may be included with the 2014 / 2015 Ford Police Interceptor Utility All-Wheel Drive vehicle or 2014 / 2015 Chevrolet Tahoe PPV vehicle (minimum 3 year / 36k mile standard warranty) and shall guarantee the vehicle and all of its parts for a period not less than sixty (60) days after date of delivery to the City of Morenci.


