### Police Vehicle Equipment and Installation

The City of Morenci is seeking sealed-bids at its office at 118 Orchard Street, Morenci, Michigan 49256, until 5:45 p.m., Tuesday, October 21, 2014 for the purchase of police vehicle equipment and installation.

### *General Specifications*

The City of Morenci requires that the following pieces of equipment for installation in either a 2014 / 2015 Ford Police Interceptor Utility All-Wheel Drive vehicle or a 2014 / 2015 Chevrolet Tahoe PPV vehicle:

1. Push Bumper
2. Pro-Gard Partition Only
3. Rear Cargo Barrier
4. Interior Light Bar – Red / Blue
5. Tailgate Light Bar – Red / Blue
6. Light / Siren Controller
7. 100 Watt Speaker
8. Police Console
9. Power Outlets
10. Cup Holders
11. Surface Mount LED – Red / Blue
12. Locking Tray
13. Single L Bracket 2"
14. Power Distribution

Installation of the above equipment would also need to occur by the successful Bidder. Bid should clearly be marked that specifies the price of equipment and the installation of such equipment and installation for one (1) vehicle only. The City of Morenci will be purchasing either a 2014 / 2015 Ford Police Interceptor Utility All-Wheel Drive or a 2014 / 2015 Chevrolet Tahoe PPV vehicle.

### *Notes to Bidders*

1. Please indicate clearly any substitutions contained in your bid and which alternates or combinations of same are included in your bid.
2. Equipment and installation is expected to begin upon delivery of the actual vehicle. Vehicle should be delivered to the City of Morenci three-to-four months after purchase.

Notice to Bidders Regarding Purchase and Installation of Police Vehicle Equipment

Installation of equipment should occur within a week and a half of the City delivering the vehicle to equipment installer.

3. Available manufacturer's service/operating literature and warranties to be provided for each and every component of this unit at time of delivery.
4. The City of Morenci will hold the successful bid prices firm for a period not to exceed six (6) months from the date of award such that an additional vehicle may be purchased under the same set of specifications and conditions, if the City so chooses.
5. Envelope(s) must be plainly marked BID, with the purpose and time of opening.
6. Bids must be submitted on the bid sheet.

Bids must be received by 5:45 p.m. on Tuesday, October 21, 2014, at 118 Orchard Street, Morenci, MI 49256.

The right is reserved by the City of Morenci to reject any and all bids or any part of same, to waive irregularities and / or informalities, and to make the award or acceptance in part or entirety as may appear to the best interest of the City of Morenci.
