ORDINANCE NO. 17 – 327

An ordinance to readopt Section 20-155 and Section 20-156 of Article VII, Chapter 20 of the Morenci City Code, to authorize the operation of golf carts on city streets pursuant to MCL 257.657a; and to provide for violations hereof and to repeal all ordinances in conflict herewith.

The City of Morenci adopted Section 20-155 and Section 20-156 of Article VII, Chapter 20 of Morenci City Code by Ordinance No. 16 – 323.

Section 2 of Ordinance No. 16 – 323 provides that unless reenacted by ordinance of City Council, Ordinance No. 16 – 323 shall be null, void and of no force and effect one (1) year after the date of its enactment.

Ordinance No. 16 – 323 was adopted on April 25, 2016, and without further action by the City, would be null and void on April 25, 2017.

The City desires to continue permitting the operation of golf carts on city streets and therefore must readopt the provisions of Section 20-155 and Section 20-156

THE CITY OF MORENCI ORDAINS:

Section 1. Readoption of Section 20-155 of Article VII, Chapter 20.

The City of Morenci readopts the provisions of Section 20-155 as previously adopted by Ordinance 16-323.

Section 2. Readoption and Amendment of Section 20-156 of Article VII, Chapter 20.

The City of Morenci readopts the provisions of Section 20-155 and Section 20-156 as previously adopted by Ordinance 16 – 323, with the following amendment:

Subsections (a) and (b) are repealed and the subsections previously number (c) through (r) are renumbered as subsections (a) through (p).

Section 3. Repealer.

All ordinances and/or parts of ordinances inconsistent with this ordinance are hereby repealed.

Section 4. Effective Date

This Ordinance shall become effective ten (10) days after its publication.
