Installation of equipment should occur within a week and a half of the City delivering the vehicle to equipment installer.

3. Available manufacturer's service/operating literature and warranties to be provided for each and every component of this unit at time of delivery.
4. The City of Morenci will hold the successful bid prices firm for a period not to exceed six (6) months from the date of award such that an additional vehicle may be purchased under the same set of specifications and conditions, if the City so chooses.
5. Envelope(s) must be plainly marked BID, with the purpose and time of opening.
6. Bids must be submitted on the bid sheet.

Bids must be received by 5:45 p.m., Tuesday, March 7, 2017, at 118 Orchard Street, Morenci, MI 49256.
